### **ADVERTISING REVIEW GUIDELINES**

- Lundberg hosted a discussion about a possible Advertising Review Policy with the Board deciding not to pursue creating one.
- Motion by Friedrichs, seconded by Chaney to allow Minnesota Inboard to continue using the WSIA Wake Responsibly message in their ads in 2024 unless the law changes. Motion approved by Chaney, Friedrichs, Lundberg, Mendel and Thoele. Motioned opposed by Birznieks, Eliason and Frawley. Motion carried.

### AIS COMMITTEE

• Thoele announced the Gull Narrows landing had 80% coverage over the recent weekends, the USACE partnership agreement has been signed, and the new decon unit has been ordered. GCOLA will be responsible for \$1K annually for decon unit maintenance.

#### **COMMUNICATIONS COMMITTEE**

• Lundberg reminded committee chairs that articles are due by 8-14-23.

### **ENVIRONMENTAL COMMITTEE**

- Eliason reviewed the Northern Waters Trust request and recommended GCOLA does not donate due to the regional focus.
- Eliason researched the potential City of Brainerd dark sky ordinance and recommended GCOLA provide input similar to other recent ordinances regarding heliport and sensitive shorelines/wetlands.

## FINANCE & AUDIT COMMITTEE

• Motion by Birznieks, seconded by Eliason to ratify the Finance and Audit Committee decision to have the Initiative Foundation utilize a 50/50 (stocks/fixed income) asset allocation mix for the Gull Chain Preservation Endowment Fund since it is more conservative than the current allocation. Motion carried.
